**Networks and Umbrellas** – Ushs.450,000/= per annum.

- NGOs having other registered NGOs as members composed as registered associations.

**National NGOs** – Ushs.150,000/= per annum

- Neither International nor umbrella and operating in more than one district

**District based NGOs** – Ushs.75,000/= per annum

- NGOs whose operational outreach does not exceed one district.
