CSO anti-corruption efforts in Uganda

On 12th September 2017, a delegation from the African Union Advisory Board on Corruption met with Mr. Richard Ssewakiryanga the Presiding Officer Economic Social Cultural Council who is also the Executive Director, Uganda National NGO Forum to get acquainted with CSO anti-corruption efforts in Uganda.

In his remarks, Mr Ssewakiryanga noted that over the years UNNGOF has been at the forefront in mobilizing citizens and organizations at national and regional level against corruption. Key initiatives include; citizen organizing on corruption through the Black Monday Movement, regional anti-corruption days, Annual Anti-Corruption Conventions and the Participatory Integrity Assessment among others. He recognized efforts of specific CSOs such as the Civil Society Budget Advocacy Group-tracks public expenditure and Transparency International- generates an annual Corruption Indices. He also made mention of the government-CSO partnerships on anti-corruption such as the Inter-Agency Forum on

Anti-Corruption under the Directorate of Ethics and Integrity, Accountability Sector working Group, Annual Anti-Corruption Week among others.

CSOs' appeal

'We appreciate that government reforms on anti-corruption are responding to issues CSOs raise but we still have a long way to go' stated Mr. Ssewakiryanga. He urged the African Union Advisory Board on Corruption to amplify CSO efforts on anti-corruption at regional level. The African Heads of State should pronounce themselves on the African Union Convention on Preventing and Combating Corruption he emphasized. Further, Mr. Ssewakiryanga pledged commitment to work with the Advisory Board to convene a presummit event in preparation for the 31st African Union Summit in January 2018.

On ECOSOCC, Mr Ssewakiryanga noted that the meeting is an opportunity to explore collaboration between the African Union Advisory Board on Corruption and ECOSOCC on efforts to curb corruption in the region.
