This session will present key insights from a comparative study on Corporate Social Responsibility (CSR) practices in Uganda, Kenya, Tanzania and across the African continent, highlighting trends, innovations, and persistent gaps in how businesses engage with social impact.

Drawing on case studies and data, the session will examine how local contexts shape CSR approaches, the extent to which corporate giving aligns with community priorities, and emerging models that blend profit with purpose. Participants will also reflect on opportunities for deeper collaboration between the private sector, philanthropy, and civil society to scale sustainable, locally rooted impact.

Amid shrinking donor funding and restrictive

youth-led organizations continue to operate without sustainable or core resources despite their central role in addressing pressing community challenges.

Drawing on the findings of Restless
Development's 2024
State of Youth Civil
Society Report
(Resourcing Youth
Power to Thrive), the session will explore innovative, community-driven, and youth-responsive funding models.

This session will engage civil society leaders in a reflective and forward-looking conversation on how CSOs can reposition themselves for greater sustainability and impact amidst shifting funding dynamics.

The session will introduce and critically examine two practical program strategy models-the social enterprise model, which leverages market-based solutions to generate income, and the systems strengthening model, which focuses on long-term structural change through collaboration and capacity building.

This session will explore the potential of building endowments as a long-term solution to the persistent financial vulnerabilities faced by civil society organisations (CSOs) in Uganda and across the region.

As donor landscapes shift and external funding becomes less predictable, endowments öffer a proactive and strategic approach to achieving financial autonomy, institutional resilience, and sustained impact. The session will unpack the concept and structure of endowment funds, examine enabling legal and policy frameworks, and draw lessons from successful models from Kenya and beyond.

It will also offer practical guidance on how CSOs can initiate, manage, and grow endowments—whether through local philanthropy, strategic partnerships, or investment instruments.
